School times are locked in upon receipt of registration fee.** Five medals and one trophy will be given to teams finishing in first, second, and third place. Medals will also be given to high series, high prone, high standing, and high kneeling scores. Additionally each team from fourth place to twenty six place will receive one medal for their team high shooter and ribbons for five shooters. If you would like more than five ribbons add an additional dollar for each extra ribbon to your registration fee.
