SUBJECT: 19th Annual North Brunswick High School Drill/Rifle/Raider

Meet on 25 February 2023

1. GENERAL:

- a. Purpose: The purpose of this MOI is to set forth rules and procedures governing the conduct of the 19th Annual North Brunswick High School Drill Meet. The provisions set forth in this document with all succeeding revisions and changes are binding on all meet participants. Entry into the meet by JROTC units indicates acceptance of the MOI and constitutes their willingness for their entries to be governed, scored, and awarded recognition by provisions of the said MOI. It is the responsibility of each unit commander to ensure that each member of his/her unit is familiar with the information contained with in this MOI.
- b. Scope: This document is applicable to all participants. Institutional SAI/AI's will ensure their cadets are familiar with its contents. Questions concerning the administration or conduct of the drill meet should be directed to COL Steven Baker, 1SG George Williams, or SFC William Bass, phone: (910-371-2261, EXT: 11027, 11036, or 11037 or FAX: (910) 371-6354.

ADMINISTRATION

- c. Schedule of events: See annex A
- b. Commanders' Caucus: A commanders' caucus will be held at 0800 25 February 2023, JROTC Department building.
- c. Eligibility:
 - (1) Units: Open to all JROTC Units
 - (2) Members: All members of a drill unit must be presently enrolled in the high school or preparatory school he/she is representing.

d. Individual, Team, Overall Awards:

- (1) Awards will be given for first, second, and third place in each of the drill events. All awards will be presented at the conclusion of the meet.
- (2) The top three teams, in each event, are determined on the basis of the highest score.
- (3) The overall trophy will be awarded to the school gathering the highest number of quality points. Quality points are awarded as follows:

First place.....	6 points
Second place.....	5 points
Third place.....	4 points
Fourth place.....	3 Points
Fifth place.....	2 points
Participant.....	1 point

(See Annex B for overall trophy criteria)

e. Registration:

- (1) Formal registration will be done on the day of the meet. This period is designed to insure accuracy of registration information as received by mail, to allow for meet participants to receive their schedules, and passing out final instructions. To avoid congestion during registration, only the SAI/AI and the designated JROTC cadet commander will perform the final registration. (see Annex A)

f. Meals: Messing facilities are not available; however, a concession stand will be available on site to provide food service on a pay-as-you-go basis.

g. Medical support: Recommend participants bring a signed medical release form should it become necessary to take anyone to a medical facility.

h. Weather: If the weather is determined to be completely prohibitive, the meet will be canceled and tentatively rescheduled for the earliest possible date.

i. Weapons: There are no restrictions on the type of weapon which can be used in the armed events. Unit commanders may be armed with an appropriate side arm or saber in lieu of a weapon. No bayonets!!

j. Uniforms: 1) All instructors, coaches, and advisors will wear the OCP uniform with soft cap. There is no exception. Judges will wear OCP's with soft cap. Teams

will be disqualified if their instructors are not in the correct uniform. 2) All cadets competing in regulation drill will wear only the Army issued OCP uniform with authorized accessories to include rank, nameplate, and ribbons (nameplates must be worn during all regulation events). All cadets must be in the same uniform (no mixed uniforms within the drill team). The only authorized head gear is the JROTC distinctive grey berets. ANY NON-STANDARD UNIFORMS ARE NOT AUTHORIZED for regulation drill. Additionally, Color Guard may wear white, green or black belts and harnesses. Color guards must use standard issued flagstaffs wood or aluminum (either eight feet or nine and one-half feet in length). Wrist/sweat bands of any type or color, spats, ascots, colored shoe laces (other than black), masks/blind folds, multi-colored gloves are unauthorized for regulation. Personal items such as watches, bracelets, ear rings as allowed by regulation may be worn by individuals.

- k. Judging of events: Regulation events will not be inspected prior to conducting the event. It is the responsibility of the SAI/AI's to ensure that cadets are in proper uniform. Although fancy individuals will not be formally inspected, appearance and military bearing will be taken into account by the judges.
- l. Scoring: Judges will score each event separately. There will be two scorers (if available) for each event area. Score sheets will be turned into the Official's Post for computation and posting.
- m. In the Event of Tie Scores, The team with the least penalties will be declared the winner. If a tie still persists, the team with the highest score on the Head Judges score sheet will be declared the winner. Finally, if a tie still persists, the OIC will use the Head Judges score sheet item by item to break the tie.
- n. Meet OIC/Official's Post: Once the meet begins, in case of a question or problem, the matter will be taken up between the Senior Military Instructor and the meet OIC. Ruling of the Drill Meet OIC is final and binding.

2. OPERATION

- a. Sequence of events: There will be several different drill areas functioning at the same time. Regulation events will occur first followed by fancy events (Annex B).
- b. Procedures: It is the responsibility of each school to monitor the progress of competition so as to be ready to report to the event ready area as soon as it is vacated by the preceding school.

- c. Time Limits: There will be no time limits applied to any regulation drill event. However, there will be a time limit of 2 to 4 minutes for fancy duet, 3 to 5 minutes for fancy squad, and 5 to 7 minutes for fancy platoon. The event time begins when the team enters the drill field and ends when the team exits the field.
- d. Each squad will consist of 7 to 11 personnel and each platoon will consist of 13 to 41 personnel.
- e. Events Procedures:
 - i. Regulation Drill
 1. The commander for all squad and platoon events must commit the sequence and appropriate commands to memory. **CADENCE** is a matter of precision and may not be verbalized in order to prevent confusion with other teams.
 2. Entry and exit points will be a point designated by the team commander. There will not be any inspection prior to events. The head judge will then position himself accordingly. Unit commanders or an individual competitor when instructed by the head judge, will enter the drill area and halt one step inside the boundary in front of and centered on the judge.
 3. When reporting in, the individual or unit commander will report by rendering a hand salute and stating "Sir, Sergeant or Drill Sergeant, (Name of school) is prepared for competition." The head judge will return the salute and judging will commence.
 4. Color Guard: The Color Guard will be in the waiting area 5 minutes before their time to compete and move into the ready area and assume the position of parade rest as the previous competing team moves into the competition area. When signaled by the head judge, the team will come to attention, carry (cased colors) and center themselves in front of the head judge by the most direct route and begin their drill sequence of UNCASING THE COLORS. Commands will be given by the Color Guard Commander (U.S. Flag Bearer). After uncasing the colors the team will Present the Colors and report in. The team commander will report out PRIOR to casing the colors. The team will then move by the most direct means to exit the drill area through the "enter/exit area".
 - ii. FANCY DRILL
 1. This competition is limited to the ingenuity of the participants. No special effects are authorized. Evaluation of fancy drill will be

based on originality, general effect, difficulty, and precision.
Music and loud speakers will not be used for any events. **(Teams are reminded that this is a drill competition and not a dance contest.)**

- (2) The drill meet officer may alter the schedule matrix in order to facilitate a more efficient and/or earlier competition of the drill meet should any unforeseen problems arise.

Annex B

CRITERIA FOR OVERALL TROPHIES

Overall Drill

1. Must compete in three regulation drill events.
2. Must compete in two fancy drill events.

Overall Raider

1. Must compete in all raider events.

Overall Drill/Rifle/Raider Meet Trophy

1. Only the teams that qualify for both Drill categories above.
2. Must compete in all raider events.
3. Must compete in rifle event.

Annex C

PENALTIES

- 1) Too few/too many team members - 25 penalty points per missing/extra team member.
- 2) Unauthorized rifles - disqualification.
- 3) Failure to stay within the prescribed drill area - 5 penalty points per occurrence.
Touching a boundary line will constitute a boundary violation.
- 4) Dropped rifles in the drill area by a competing unit - 25 penalty points per person per occurrence.
- 5) Extra commands - (Regulation Drill and Color Guard) - 5 penalty points per extra command.
- 6) Commands given out of sequence in Regulation Drill and Color Guard events - no points will be scored on the score sheet for each missed command.
- 7) Discharge of weapons or possession of igniting pyrotechnic devices - disqualification.
- 8) Teams performing to music - disqualification.
- 9) Stacking of cadets, elevating cadets or suicide throws during Exhibition Drill - disqualification.
- 10) The Color Guard will be commanded by the U.S. Flag Bearer or the team will be disqualified.
- 11) Any case of unsportsmanlike conduct involving team members or Coaches/Advisors, the OIC will determine the severity of the infraction and may assess any penalty up to and including disqualification.
- 12) Any team Coach/Advisor or team member approaching a judge with the intent to influence the competition, or who enters the drill area without permission will cause his or her team to be immediately disqualified, except in the event of an emergency (i.e. cadet faints).
- 13) Failure to observe the OIC's final decision on a protest will result in immediate disqualification.

Annex D

SCORE SHEETS AND EXPLANATION OF GRADING

1. Color Guard: The color guard report in. Grading begins and ends when the color guard crosses the boundaries. Grading will be in accordance with the respective score sheet.
2. Regulation Platoon: The unit commander will report in centered on the head judge. Grading will begin when the unit commander reports in and will end when the team exits the drill area. Grading is in accordance with the respective score sheet.
3. Regulation Squad: The unit commander will report in centered on the head judge. Grading will begin when the squad leader reports in and will end when the squad exits. Grading is in accordance with the respective score sheet.
4. Exhibition Events: Commence their sequence upon command. Timing and grading will begin and end when the individual/team crosses the boundary lines respectively. Grading will be in accordance with the respective score sheet.
5. Judging and Scoring: There will be two judges (if available) using the score sheets in Annex E and the penalty sheet in Annex C. All the score sheets will be added for the teams' final score in that event.

MEMORANDUM FOR: Raider Team Captains

SUBJECT: Memorandum of Instruction for the NBHS Raider Challenge.

1. **PURPOSE:** To provide guidance for the conduct of the NBHS Raider Challenge competition on Saturday, 25 February 2023 in Leland, North Carolina.
2. **REFERENCES:**
 - a. CC Regulation 385-10, Cadet Command Safety Program
 - b. FM 21-20, Physical Fitness Training
 - c. FM 3-97.61, Military Mountaineering
 - d. Cadet Command Regulation 145-2
 - e. Cadet Reference Guide Version 4
3. **OBJECTIVES:**
 - a. To promote esprit de corps, teamwork and self-confidence amongst JROTC cadets.
 - b. To provide JROTC cadets a competitive program in five mentally and physically challenging training events: 5 Kilometer Road March, Litter Carry, Physical Fitness Challenge (PFC), One-Rope Bridge, and HUMMV-Pull. All score sheets and further instruction will come from the 4th Brigade Standard Operating Procedures.
 - c. To serve as a JROTC cadet recruiting and retention vehicle.
4. **GENERAL INFORMATION:**
 - a. The administrative and safety briefing will begin at 0800 hours on the football field and closing ceremony at approximately 1600 hours in the NBHS gymnasium.
 - b. Team Composition: Teams will consist of 9 Cadets with 8 competing in any event. Between events, the 9th team member can be rotated out at the discretion of the team captain. The same eight that start an event must finish that event.
 - c. Teams must report to test headquarters, NBHS football field at 0800 hours. Team rosters, SAI/AI Statement, Cadet Personal Information, Covenant Not to Sue and Power of Attorney forms should be on hand, but will not be turned in.
 - d. After the score events a Tug of War will conclude the competition. Trophies will be awarded for the top three teams. The tug of war will not count towards the overall score.

- e. All units are responsible for their own transportation to and from the competition. Once units arrive at the competition, all other transportation will be by foot.
 - f. Team placement will be in one of two divisions for BOB and BOB qualifiers,
 - 1) CO-ED Division- For a team to be considered and remain CO-ED, the team must consist of 9 cadets with at least 4 females and 3 females that must compete in each event.
 - g. If a team starts the competition with 9 members and only 4 are female, if one female has to be transported off site due to an injury or any other reason, the team will no longer be considered a COED team. This team will be considered a Male team for the competition. The hosting school will transfer the scores of this team to the Male division.
 - h. Class I will not be provided, however concessions will be sold.
 - i. All score sheets and regulations will be taken directly from the 4th Brigade Standard Operating Procedures for the Raider Challenge.
5. SCORING:
- a. Overall scoring will be conducted as follows: All teams will be ranked on team performance against the entire field for each event. A point value will be awarded based on the individual team's place in the event. The overall winner of the competition will be the team with the least amount of total points for the entire competition. Additionally, in the event of a tie score, the 5K Road March time will be used to decide the final outcomes.
 - b. Complaints are to be handled as follows:
 - (1) SAI/AI and Cadets Team Captains are the only individuals authorized to file a complaints
 - (2) Complaints must be filed with the event prior to leaving that station. If the team leaves the station, the complaint will not be heard.
6. CONCEPT:
- a. Concept of Operations: Teams must report to test headquarters NLT 0800 hours. Team Rosters will be submitted at that time.
 - b. Sequence of Events:
 - (1) 0730-0745 Report with teams and necessary paperwork will be issued.
 - (2) 0800-0815 Administrative and Safety Briefing.
 - (3) 0815-0945 5K Road March
 - (4) 0945-1530 Remaining events in accordance with rotation schedule.
 - (5) 1600 Awards and Closing Ceremony
7. UNIFORM AND EQUIPMENT:
- a. Uniform: Uniform for participants is OCP's (tan Army T-shirt or team shirt), boots, appropriate headgear, pistol belt, and one canteen with cover. Hydro packs may be substituted for the pistol belt and canteen. Running shoes(used for the 5K only), OCP trousers and team T-shirt (as long as they are all the same) are required for the 5K. **NO PT uniforms!** Non-Army JROTC units will wear their OCP equivalent.

- b. Equipment:
 - (1) Bridging equipment-each team will provide their own ropes, snap links and Swiss seat ropes. All equipment will be inspected for serviceability by SAI/AI. The minimum rope length must be 100 feet.
 - (2) Guidon-fully assembled on a pole and visible throughout the event.

- 8. CADET LIABILITY: Senior Army Instructors must ensure that each cadet participating in Raider Challenge training or competition understands the requirements for personal medical coverage. Raider Challenge team members must complete all forms prior to participating in Raider Challenge. **Coach must be with the team.**

- 9. SAFETY:
 - a. Responsibility: Commanders at every echelon are responsible for conducting a continuous, rigorous safety program ensuring that adequate provisions for safe practices and safe physical standards are incorporated into all aspects of training.

 - b. Safety Requirements:
 - (1) Risk Management Program methodology will be incorporated into training and competitions.
 - (2) Cadet Buddy Teams and the “Buddy Team” process will be incorporated into training and competitions.
 - (3) Applicable training safety publications will be available and adhered to during training and competitions.
 - (4) All cadre and cadets will be thoroughly briefed on pertinent safety and range regulations prior to the start of the competitions. Additionally, each event OIC will conduct a safety briefing for cadets prior to the start of each event. Competition evaluators must attend the briefings.

- 10. A registration fee of \$60.00 per team is required to enter into the Raider Meet competition. Additional teams will be notified after 17 January if it has a slot. Registration will be limited to the first 25 teams. Please no more than one team per school. Please return the attached registration form to reserve a place for your team in the competition. Checks made payable to: NBHS JROTC Department.

MEMORANDUM FOR: 19th Annual North Brunswick High School Drill/Rifle/Raider Meet 25 February 2023.

1. This memorandum outlines the rules, policies, and procedures for the rifle competition at the 19th Annual Scorpion Invitational Drill/Rifle/Raider Meet. Firing orders will start on Wednesday February 22 and continue each day until Saturday February 25.
2. A school team will consist of 4 shooters. An entire team will be placed on the firing line to shoot alongside a team from another school. The aggregate score of all team members will be used to determine the team score. Matrix will follow and sign up for dates will start on December 1, 2022.
3. Shooters will fire thirty (30) record shots, ten (10) shots from each position (prone, standing, and kneeling) at an electronic target. The shooters will have ten (10) minutes for preparation, eight (8) minutes for sighters, ten (10) minutes for prone, five (5) minutes for preparation, five (5) minutes for sighters, fifteen (15) minutes for standing, five (5) minutes for preparation, five (5) minutes for sighters, and ten (10) minutes for kneeling position. Targets will be 33 feet from the firing line. All shooters must remain on the line until the firing line is cleared.
4. NRA 3-position air rifle rules will govern the match unless otherwise outlined in this memorandum. The only sporter rifles authorized are the 853, 753, T200, 887, Crossmans, and the Xs 40. No shooting jackets or pants will be allowed. Slings will not be used when firing from the standing position. Verbal coaching will be allowed during the zero period only. Non-verbal coaching is allowed after "Fire" command is given for record fire.
5. The host school will provide Sius electronic targets. Visiting teams must bring their own air rifles and shooting gloves, pellets, ect.

6. Scoring will be conducted by the host school, using an electronic scoring system.
7. **Scoring will be done utilizing the Orion and Sius scoring system. Targets for that system will be electronic. Teams entering this part of the competition are requested to register their shooters with CMP and be prepared to provide the CMP number and additional information by 16 January. Information for additional teams is required upon registration. You will receive specific instructions.**
8. Trophies will be awarded for 1st through 3rd place teams, top 3 shooters in each position and overall.
9. The registration fee of \$60.00 per team is required to enter the rifle competition. Please no more than one team per school prior to 16 January. Registration will be limited to the first 24 teams. You may request additional slots but they will not be given out until 23 January. Please return the attached registration form to reserve a place for your team in the competition. Checks should be made payable to North Brunswick JROTC. Teams may call after 23 January to enter additional teams (space permitting).
